# Information regarding the use of cookies

#### What are cookies?

In order to provide a customized visitor experience the website of Crossroads Coaching / Nicole Buitenhuis (registered: 1037 Budapest, Perenyi ut 18a; tax ID 69720873-1-41) uses anonymous user identifiers, so-called cookies. Cookies are pieces of computer code (files storing information) placed by service providers on the users' computers that facilitate user identification, the storage of profile information and also enable the website to record details about the browsing habits of the user (e.g. to store the user's preferences and settings, help logging in, display customized advertisements and analyse the operation of the website). However, the code stored in the cookie alone is only suitable for the recognition of the user's computer and cannot individually identify the user.

Thanks to the use of advanced encryption methods the contents of cookies are safely protected against access by third parties. The cookies used on the website of Crossroads Coaching / Nicole Buitenhuis do not contain viruses and will not damage your computer. We inform our users that pursuant to Act C. of 2003 on Electronic Communications (Eht.) and to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, "GDPR") the use of the cookies on our website is subject to the previous, informed consent of users. Therefore, on the occasion of the first visit of the user a notice pops up to inform the user that Crossroads Coaching / Nicole Buitenhuis uses cookies and displays a link leading to the present information. Users can give their consent to the use of cookies by clicking the YES button. In lack of such consent or in the event an earlier consent is revoked our website will not store cookies on the user's device.

We use the following cookies on the website of Crossroads Coaching / Nicole Buitenhuis:

#### Session cookies

This type of cookies are created strictly for the duration of your visit and are deleted automatically when you end your session. Their purpose is to make our website more user friendly and safe. Session cookies use identifiers related to the specific browsing session and expire at the end of the session at the latest (they are temporary cookies with a life span of a few hours). They tracks the data entered by the user, e.g. the contents of online forms or of a virtual shopping cart. The service provider needs these cookies to provide information society services specifically requested by the user and the cookie is related to the user's activities (such as filling in a form or clicking a button).

Expiration: At the end of the browsing session.

The following session cookies are used on our website:

#### External cookies

In the course of your use of this website third party cookies may be placed on your device to assist you in sharing content in social media sites or in compiling traffic statistics. When the browser returns a previously saved cookie the service provider managing that cookie can link the current visit of the user to their earlier visits to websites using the cookies of the third party service provider.

Google Analytics: The independent measurement and auditing of the traffic and other data of website analytics is helped by external servers (www.google.com/analytics/). #### Basis and term of data processing, identity of the data controller and rights of the Data Subject

- Rights of the Data Subject: The Data Subject may request access to, rectification, deletion and limitation of processing of personal data pertaining to the Data Subject and may also revoke its consent to the processing of its personal data at any time. Crossroads Coaching / Nicole Buitenhuis (registered: 1037 Budapest, Perenyi ut 18a; tax ID 69720873-1-41) shall respond do Data Subject requests without undue delay but in any case not later than within one month.

Should it refuse to comply with such request it shall give the reasons of such refusal. We do not use the information stored in cookies to determine your identity and all data collected by cookies are entirely under our control. Information stored in cookies will be used for the purposes described herein only.

Should you decide not to accept cookies of certain type, then you can set up your browser to prevent storing them or to warn you if a website attempts to send a cookie to your computer.
